Lodging Nominations

Nominations open 12:00 midday Australian Eastern Standard Time (AEST) 02/03/2026 and must be received by the Returning Officer no later than 12:00 midday Australian Eastern Standard Time (AEST) 23/03/2026.

Rule: Section 5 29 (e) At least 50% of the Convention Delegates must be women.

Nominations cannot be withdrawn after 12:00 midday (AEST) on 30/03/2026.

Prospective candidates should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must be lodged via the following method(s):

- 3.1 When sending nominations via email, please use the subject line as:

3.2 If a candidate would like a third party to submit their nomination form on their behalf, they should email IEBnominations@aec.gov.au with the full name and email address of the third party. This email should provide the candidate's authorisation for third-party submission.

IMPORTANT INFORMATION ON EMAILS:

3.3 Emails that appear to be spam may be blocked. It is the sender's responsibility to ensure their nomination email is delivered to the returning officer before the deadline.

3.4 Emails and attachments must not exceed 6 MB in total size.

Acknowledgment

You will be sent an acknowledgment of receipt of your nomination by email.

Team Nomination instructions

- The Team Name must not be the same as, or similar to, the name of another team or otherwise be deceptive (Rule 7(c) of Schedule 4).
- This Team Nomination form must include a nominee for **every position** in the election (Rule 7(e) of Schedule 4).
- A Team Nomination must be in writing and signed by each Candidate in each respective election (Rule 7(f) of Schedule 4).
- Each Team Nomination must specify its contact person for communicating with the Returning Officer over matters associated with the ticket nomination, including the rectification of a defective nomination (Rule 7(g) of Schedule 4).
- A nomination must be in writing, signed by the candidate and endorsed by at least two (2) Financial Industrial Members and given to the Returning Officer before nominations close (Rule 6(a) of Schedule 4).
- Candidates who have signed this form consent to the nomination for the below office for which they are eligible under the rules and are not disqualified from being a candidate {see Chapter 7, Part 4 of the Fair Work (Registered Organisations) Act 2009}.
- Print your name as you wish it to appear on the **ballot paper**
