Lodging Nominations

Nominations open on 06/07/2026 and must reach the Returning Officer, Danny Cloghan not later than 12:00pm Australian Eastern Standard Time (AEST) on 13/07/2026.

A nomination must be in writing, signed by the candidate and endorsed by at least two (2) (Financial) Convention Delegates and given to the Returning Officer before nominations close (Rule 6(a) of Schedule 4, r 74 (e)).

Prospective candidates and nominators should verify their financial status and any other qualifications required by the United Workers Union's rules prior to lodging nominations.

The subject line of the email should include the reference 'UWU Member Council nomination – your name & region'
