- The Team nomination must be in writing, signed by each candidate and endorsed by at least two (2) (Financial) Convention Delegates and given to the Returning Officer before nominations close (Rule 6(a) of Schedule 4, r 74(e)).
- Candidates who have signed this form consent to the nomination for the above office for which they are eligible under the rules and are not disqualified from being a candidate {see Chapter 7, Part 4 of the Fair Work (Registered Organisations) Act 2009}.

**Lodging Nominations**

Nominations open on 06/07/26 and must reach the Returning Officer, Danny Cloghan, not later than 12 noon AEST on 13/07/26.

Prospective candidates should verify their financial status and any other qualifications required by the United Workers Union's registered rules prior to lodging nominations.

Nominations must be lodged as follows:
